Terms of use

Welcome to terms of use (hereinafter – "**Terms**") of Prospectors Project (hereinafter – "**Prospectors**," "**Game**" or "**We**" and its derivatives). These Terms along with Prospector's Privacy Policy govern the relationship between You and Prospectors regarding your use of the Game on our website https://prospectors.io/ (hereinafter – "**Game**", "**Services**"), and affect your obligations and legal rights, including, but not limited to waivers of rights and limitation of liability.

Prospectors.io is a desktop project of Wecan Dev Pte. Ltd., a company duly incorporated in Singapore, that runs on blockchain. All game activity happens within the project's smart contract, and all the assets, owned by a player, are secured to him in the blockchain.

The term "You" refers to You individually or the legal entity on whose Prospectors Project Services are used, as applicable.

You must agree to these Terms and Prospector's Privacy Policy before accessing or using the Game. By accessing the Game you agree that you are age 18 or older. IF YOU ARE UNDER THE AGE OF 18, OR THE LEGAL AGE OF MAJORITY WHERE YOU RESIDE IF THAT JURISDICTION HAS AN OLDER AGE OF MAJORITY, THEN YOU AGREE TO REVIEW THESE TERMS WITH YOUR PARENT OR GUARDIAN TO MAKE SURE THAT BOTH YOU AND YOUR PARENT OR GUARDIAN UNDERSTAND AND AGREE TO THESE TERMS. YOU AGREE TO HAVE YOUR PARENT OR GUARDIAN REVIEW AND ACCEPT THESE TERMS ON YOUR BEHALF. IF YOU ARE A PARENT OR GUARDIAN AGREEING TO THE TERMS FOR THE BENEFIT OF A CHILD UNDER 18, THEN YOU AGREE TO AND ACCEPT FULL RESPONSIBILITY FOR THAT CHILD'S USE OF THE APP, INCLUDING ALL FINANCIAL CHARGES AND LEGAL LIABILITY THAT HE OR SHE MAY INCUR. Prospectors has the right to make changes to these Terms at any time. If you continue to use the Services it will be deemed as confirmation of your acceptance of the updated terms. In addition to these Terms, you agree to abide by any additional policies of the Games, such as policies related to specific services (including without limitation forums, chats) as well as all other related operating rules or policies, each of which is incorporated by reference where applicable.

Prospectors is using WAX and EOS (hereinafter – "Smart Contracts") in order to interact with users. Users can buy, sell, manage items and profile via website https://prospectors.io/ (the Site). All user interaction happens via Smart Contracts that allow users to buy, transfer, sell in-game assets.

PLEASE READ THESE TERMS CAREFULLY BEFORE USING OR ACCESSING THE SERVICES, SMART CONTRACTS. THESE TERMS GOVERN YOUR USE OF THE SERVICES, SMART CONTRACTS UNLESS WE HAVE EXECUTED A SEPARATE WRITTEN AGREEMENT WITH YOU FOR THAT PURPOSE. WE ARE ONLY WILLING TO MAKE THE SERVICE, SMART CONTRACTS AVAILABLE TO YOU IF YOU ACCEPT ALL OF THESE TERMS. BY USING THE SERVICES, SMART CONTRACTS OR ANY PART OF THEM, YOU ARE CONFIRMING THAT YOU UNDERSTAND AND AGREE TO BE BOUND BY ALL OF THESE TERMS. IF YOU ARE ACCEPTING THESE TERMS ON BEHALF OF A COMPANY OR OTHER LEGAL ENTITY, YOU REPRESENT THAT YOU HAVE THE LEGAL AUTHORITY TO ACCEPT THESE TERMS ON THAT ENTITY'S BEHALF, IN WHICH CASE "YOU" WILL MEAN THAT ENTITY. IF YOU DO NOT HAVE SUCH AUTHORITY, OR IF YOU DO NOT ACCEPT ALL OF THESE TERMS, THEN WE ARE UNWILLING TO MAKE SERVICE, SMART CONTRACTS AVAILABLE TO YOU.

If you do not agree to these Terms, you may not access or use the Services.

1. In-game Assets

All game activity happens within the project's Smart Contract, and all the in-game assets, owned by a User, are secured to him in the blockchain. Within the Game the Users do not send or receive money. Gold is an in-game assets that can be used to buy and sell in-game assets such as Map, Plot, Workers, Buildings, Resources, Materials, Tools, Transport, Speed boost (hereinafter – "Assets") within the Game. The external representation of gold is PGL. In case of depositing 1 PGL token in the game, a User receives 1 000 of the game Gold. In case of withdrawing 1 000 of game Gold, a User receives 1 PGL.

All Assets are two sided items that can be owned by User as NFT (Non fungible token).

2. Digital Asset Protocols

Prospectors does not own or control the underlying software protocols which govern the operation of digital currencies. You acknowledge and agree that Prospectors is not responsible for operation of the underlying digital asset protocols and that Prospectors makes no guarantee of their functionality, security, or availability.

3. Managing Your Keys

Prospectors does not control any private keys. You are solely responsible for maintaining the security of the other two private keys.

4. Passwords and Security

You are responsible for maintaining adequate security and control of any and all log in IDs, passwords, private keys, personal identification numbers (PINs), and any other codes that you use to access the Account. You will be solely responsible for the private keys that we provide to you or that you generate for your wallets, and maintaining secure back-ups. You will prevent unauthorized access to or use of the Services using your account credentials or private keys, and notify us promptly of any such unauthorized access or use. You must keep your account ID, passwords and any other account credentials confidential and not authorize any third party to access or use the Service on your behalf, unless we provide an approved mechanism for such use.

5. Payments and Transactions

You may purchase or interact with Assets on the Site, in this case any financial transactions that you engage in will be conducted solely through the supported blockchain network. We will have no control over these payments or transactions, nor do we have the ability to reverse any transactions. Referring to that, we will have no liability to you or to any third party for any claims or damages that may arise as a result of any transactions that you

engage in via the Site, or using the Smart Contracts, or any other transactions that you conduct via the blockchain network or wallet.

You will be solely responsible to pay any and all sales, value-added, use and other taxes, duties, and assessments (except taxes on our net income) now or hereafter claimed or imposed by any governmental authority (collectively, "Taxes") associated with your use of the Site (including, without limitation, any Taxes that may become payable as the result of your ownership, transfer, or acquisition of your Gold). Excluding the income taxes levied on Prospectors, you: (i) will pay or reimburse us for all national, federal, state, local or other taxes and assessments of any jurisdiction, including value added taxes and taxes as required by international tax treaties, customs or other import or export taxes, and amounts levied in lieu thereof based on charges set, services performed or payments made hereunder, as are now or hereafter may be imposed under the authority of any national, state, local or any other taxing jurisdiction; and (ii) shall not be entitled to deduct the amount of any such taxes, duties or assessments from payments made to us pursuant to these Terms.

6. User Account

A User cannot create several player accounts simultaneously, but a User can have one account per every game world. A User cannot provide access to his/her game account to third parties. Using multi-accounts will be punished by blocking the account. A violator will lose all his in-game possessions in favor of the Prospectors. To prevent suspicion in the multi-accounts violation a Users should not use the same gadgets with other players.

7. Ownership

a. Intellectual Property Right

All rights, title and interest in and to the Game (including without limitation any computer code, titles, themes, objects, characters, names, dialogue, concepts, artwork, animations, audio-visual effects, sounds, musical compositions, documentation, in-game chat transcripts, recording of games played using Prospectors's game clients) ("Prospectors Property") are owned by or licensed to Wecan Dev Pte. Ltd., subject to copyright and other intellectual property rights under Singapore laws and international conventions. Prospectors reserves all rights, including without limitation, all intellectual property rights or other proprietary rights, in connection with its games and the Service. Except as expressly provided in the Terms, Prospectors does not grant any express or implied rights to the Prospectors Property.

Except as expressly set forth herein, your use of the Site, Smart Contracts does not grant you ownership of or any other rights with respect to any content, code, data, or other materials that you may access on or through the Site. We reserve all rights in and to the Prospectors Property not expressly granted to you in the Terms. For the sake of clarity, you understand and agree:

(i) that your "purchase" of an Assets, whether via the Site or otherwise, does not give you any rights or licenses in or to the Prospectors's Property (including, without limitation, our copyright in and to the art and drawings) other than those expressly contained in these

Terms; and (ii) that you do not have the right to reproduce, distribute, or otherwise commercialize any elements of the Prospectors's Property (including, without limitation, our copyright in and to the art and drawings) in any way without our prior written consent in each case, which consent we may withhold in our sole and absolute discretion.

b. Feedback

You may choose to submit comments, bug reports, ideas or other feedback about the Game, including without limitation about how to improve the Game (collectively, "Feedback"). By submitting any Feedback, you agree that we are free to use such Feedback at our discretion and without additional compensation to you, and to disclose such Feedback to third parties (whether on a non-confidential basis, or otherwise). You hereby grant us a perpetual, irrevocable, nonexclusive, worldwide license under all rights necessary for us to incorporate and use your Feedback for any purpose. 8. Suspension and Termination of Account and Services

You shall have a right to terminate your Account at any time by canceling and discontinuing your access to and use of the Services. We may terminate or suspend all or part of the Services and your access to the Services immediately, without prior notice or liability. You will not receive any refunds if you cancel your Account, or if these Terms are otherwise terminated.

Your use of the Game is strictly tied to your compliance with these Terms. The game and game worlds are created for entertainment and should cause positive emotions only. Prospectors reserves the right to use specific programs and trained personnel to detect any violations of the rules and identify a User in case of a grounded suspicion of the Term' s violation.

You agree that you will not, under any circumstances:

- use the Services for fraudulent or abusive purposes (including, without limitation, by using the Services to impersonate any person or entity, or otherwise misrepresent Prospectors's affiliation with any person, entity or the Services);
- interfere with or disrupt the Services, servers or networks that provide the Services
- post any information that is abusive, threatening, obscene, defamatory, libelous, or racially, sexually, religiously, or otherwise objectionable or offensive or engage in ongoing toxic behavior, such as by repeatedly posting information on an unsolicited basis

The violation of any rules and obligations can be punished by the immediate temporary blocking or deletion of the game account, depending on the severity of the violation. In the case of detecting the breach, the Prospectors representative will investigate the consequences of such violation in every separate case. A User acknowledges that the representative's decision is definite. Additionally, a User acknowledges that Prospectors cannot reveal the mechanisms it uses to detect violations since they can be easily circumvented otherwise. Prospectors reserves the right to forbid the subsequent registration in the game after the blocking or deletion of the game account on other game servers.

- b. You are solely responsible for determining what, if any, taxes apply to your Prospector's -related transactions. Prospectors is not responsible for determining the taxes that apply to your transactions on the Site, or the Smart Contracts.
- c. The Site does not store, send, or receive Assets. This is because Prospectors exists only by virtue of the ownership record maintained on the Site's supporting blockchains. Any transfer of Prospectors assets occur within the supporting blockchain in the supported network, and not on the Site.
- d. There are risks associated with using an Internet-based currency, including, but not limited to, the risk of hardware, software and Internet connections, the risk of malicious software introduction, and the risk that third parties may obtain
